and/or Students, herein referred to as "WMA," and defined as a dog agility training and recreation school open to many people with dogs of all types and descriptions, both with and without training, EACH OF THE UNDERSIGNED, for herself or himself, and personal representatives, assignees, heirs and next of kin, UNDERSTANDS, ACKNOWLEDGES, AGREES AND REPRESENTS that, because attendance or participation at WMA is not without risk to myself, my family or guests who may attend, my property or my dog, because of the very nature of such an environment for reasons including, but not limited to, the fact that some of the equipment and dogs to which we will be exposed may be difficult to control and may be the cause of loss, damage or injury, even when handled with great care, and because even circumstances involving friendly, playful dogs with a high level of training does not change the unpredictability of animals and events in such a varied environment, WMA cannot and does not assume responsibility for any aspect of the safety of persons, dogs or property, and the Undersigned's attendance or participation at WMA is done voluntarily based on the Undersigned's own assessment of his or her ability and all facilities and conditions, and assuming full responsibility for any and all risk at all times upon entering and while in or about WMA premises for whatever purpose, and:					
1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the WMA, its owners, operators, promoters, sponsors, instructors, the owners and lessees of the premises used for agility, and for each of them, their officers, directors, employees and agents, all for the purposes herein referred to as "RELEASEES," from all liability of any type to each of the Undersigned, his or her personal representatives, assignees, heirs and next of kin for any and all claims or demands therefor on account of any and all loss, damage, injury or death, which I, my family, my guests, my property or my dog may suffer, whether caused by the negligence of the Releasees, the direct or indirect result of the actions of any dog, including my own, or from any cause whatsoever while the Undersigned is in or about the WMA premises for any reason and/or competing, officiating, observing, assisting, working for or for any other purpose participating in any manner in WMA activities; and 2. HEREBY AGREES THAT THIS ENTIRE AGREEMENT SHALL BE GOVERNED AND CONSTRUED according to the laws of the STATE OF NEW HAMPSHIRE, and is intended to be as broad and inclusive as is permitted by the laws of that State, and that if any portion of this Agreement is held to be invalid it is agreed that the remainder shall, notwithstanding, continue in full legal force and effect and that any action arising out of or relating to this Agreement or the action or alleged negligence of the Releasees shall be litigated in the courts of New Hampshire.					
The ndersigned, for herself or himself, further understands, acknowledges and agrees that, with respect to the attendance or participation at WMA of the Undersigned and/or his or her dog:					
WMA officials have the right to take whatever action they determine in their sole discretion, individually or collectively, to be appropriate and necessary whether in the best interests, as they determine, of individual persons or dogs, or of WMA and/or its attendees or participants as a whole, including but not limited to refusing entry to or participation in any WMA activity of whatever type. Each of the Undersigned further certifies, for himself or herself, that the following statements are also true and correct, and that she or he further understands that they were also relied upon by Releasees in granting permission to attend and participate at WMA:					
 Dog control is the sole responsibility, at all times, of the person who brought the dog to WMA; and No oral representations, statements or inducements from or by Releasees apart from this written Agreement have been made; and He or she agrees to follow all WMA rules at all times while attending or participating in agility or on WMA premises or surrounding areas for any reason whatsoever; and He or she is eighteen (18) or more years of age, or is participating in WMA activities under the direct supervision of another Undersigned who accepts full responsibility for him or her and with the full and informed consent of a parent or legal guardian who is also an Undersigned; and
